TACK SWAP SELLER AGREEMENT

By signing below, Seller agrees to and acknowledges the following terms and conditions:

1. **RIGHT TO SELL.** Seller will be assigned a Seller No. after paying the nonrefundable \$10 Seller Fee and signing this Agreement. All items (“Tack Swap Items”) must be listed individually on the Seller’s Tack Swap Item List, which becomes a part of this Agreement. Seller certifies that Seller is the rightful owner and has the full lawful right to sell any Tack Swap Items submitted.
2. **SPACE; COMMISSION.** Seller is allowed up to 24 sq. ft. of space for Tack Swap Items. LIMIT TWO Seller Nos. per person. If Seller wishes to receive store credit, SCS will deduct a 25% commission from the proceeds of sold Tack Swap Items, and Seller will receive 75% of the proceeds from Seller’s sold Tack Swap Items as store credit on Monday 11/11/24. If Seller wishes to receive a check, SCS will deduct a 35% commission from the proceeds of sold Tack Swap Items, and Seller’s check for 65% of the proceeds will be ready by Tuesday 11/12/24. **Please check here if you would like store credit instead of a check.**
3. **NO EARLY REMOVAL.** Tack Swap Items must remain on SCS premises through Monday 11/11/24 to allow staff to collect and reconcile unsold items, and may not be removed early for any reason.
4. **DROP OFF/PICK UP TIMES.** Tack Swap Items may be dropped off ONLY at the drop off times specified below. Unsold Tack Swap Items must be picked up at the pick up times specified below (sorry, no exceptions). Unsold Items that are NOT picked up by 11/14/24 will be considered DONATED and may be handled by SCS as it deems fit. Checks will NOT be mailed, but SCS can hold them for later pick up if requested.

DROP OFF TIMES: Tuesday 11/5/24 – Thursday 11/7/24 from 9:00AM – 7:00PM.

PICK UP TIMES: Tuesday 11/12/24 – Thursday 11/14/24 from 9:00AM - 7:00PM.

5. **DESIGNATED PICK UP PERSON.** If Seller is unable to pick up Seller’s unsold Tack Swap Items, Seller may designate one person below with authority to pick up Seller’s unsold Tack Swap Items and payment check during the pick up times. Please advise the Designated Person to carry identification.

6. **NO LIABILITY.** SCS **does not insure the Tack Swap Items and is not responsible for loss, theft, normal wear and tear, or any damage that occurs to the Tack Swap Items.** Seller agrees to hold SCS harmless and release SCS from liability in all such cases. Hangers, bins, packaging, and other containers will not be returned to Seller and should not be left at SCS if Seller wants them back.
7. **CONDITION OF ITEMS.** Tack Swap Items must be CLEAN and in GOOD REPAIR, and horse-related. Items that do not meet the terms of this Agreement may be rejected by staff and not put out for sale.
8. **UNACCEPTABLE ITEMS.** Items that will NOT be accepted as Tack Swap Items include, without limitation:
 - Sharp items (knives, needles, etc.)
 - Helmets or air vests
 - Items less than \$2 (except books)
 - Consumables and liquids
 - Saddles
9. **TAGGING.** All Tack Swap Items must be securely tagged with the cardstock tags provided by SCS. Seller is responsible for making sure the Seller No. and Item No. is correctly specified on each tag.
